Message from President Murray Scharf:

Now that the regular term is over, we can plan and organize the activities we wish to undertake in partnership with the International Student Services Division. Our desire to establish an emergency support fund for

international students is known to the Development Office.

We have made good progress on our partnership with the sessional lecturers. The Executive has approved their eligibility; the invitation has been extended to the sessional's union executive; and, they have circulated a notice among their members of their eligibility for membership in USRA.

At our Valentine's Day meeting with President MacKinnon, we received much encouragement to pursue our strategic plan and affirmation of the importance of the role USRA can play in the life of the University of Saskatchewan. It was clear that USRA enjoys the support of the President.

Since February, the Executive has mainly directed its attention to many internal matters. First, our offices have been moved within the Williams Building to Room 310. The mailing address and phone number remain unchanged. The advantage of the move is access to a kitchen and a board room.

In order to improve access to the Retirees' Lounge in the College Building, efforts are being made to have the door unlocked during the business hours. Currently, you must go to the President's Office to have a receptionist unlock the room.

Both of these moves should ensure our physical presence on campus and facilitate our activities.

The educational presentations by Michael Pomedli, on February 28th, George Sofko, on March 27th, and Richard Schwier, on April 26th, were well attended and very well received. The Manos Restaurant venue and luncheon format appear to work well with the presentations; and the campus venue on Saturdays appears to work well for workshops. The Canadian Light Source tour in May, of necessity, must be on campus. (The notices of these events are included in this newsletter.)

Soon we will be working on our program for 2008-2009 so if you have some suggestions on possible activities or events, please forward them to Nora Carey care of the USRA office. We believe the monthly schedule of events has been a positive move.

USRA can only progress if we have the support of our members and have a strong Executive. We are approaching that time of year when we must nominate individuals to the Executive and obtain a renewed list of volunteers for the various activities. University Retirees Lounge on Campus!

When the College Building (Admin Building) was re-opened, Room 132 on the ground floor was set aside for the use of University retirees as a lounge and meeting place. The room has comfortable chairs and facilities for making coffee and tea. It is open for use during University business hours. When you are on campus, drop in for a visit. We encourage retirees to make use of the lounge. If the door is locked, go to the University Secretaries office (212) to obtain a key.

The following was submitted by Murray Scharf as an information item concerning programs that provide support to those in need of assistance in our city:

Cheshire Homes of Saskatoon is investigating the possibility of a new housing option in Saskatoon for young adults with physical disabilities. The intent is to fill a niche for individuals who require attendant care services but want more independence and living space than would be available in a nursing home or group home setting. The idea is to construct a building with perhaps 6 to 8 accessible condo-style units with access to 24 hour on-site attendant care services to be provided by Cheshire. Preliminary plans have been drawn up to illustrate how the units might look, which can be viewed on the Cheshire Homes website at

www.cheshirehomessaskatoon.c

om. On these plans there are six smaller units of 548 square feet and two larger units of 743 square feet. Each unit would have its own bedroom, bathroom, living space and small kitchen area. There would be a central laundry and kitchen with some common space available for meetings or gatherings.

These plans will be further modified and developed in consultation with the individuals who express an interest in the project. The building would be constructed on Cheshire's existing property in the quiet residential neighbourhood of Eastview. Funding options are currently being investigated. One possibility is for individuals to purchases a life lease in a unit, which they or their estate are able to sell at whatever the market value is, and also pays a monthly amount to cover the typical condo fees, food, and to contribute to the cost of the attendant care services. This project is in the early stages of this project and Cheshire is looking for feedback and expressions of interest from those who are interested in this concept.
