Message From President Murray Scharf :



On behalf of the Executive Committee, I wish all USRA members and their families a very happy and healthy New Year. For all of us on the money-purchase pension, may the stock market recover and, again, may we experience a return on our investments. For those of you on the defined-benefit pension, stop laying claim to the "Crown of Self-Righteousness" – to misquote II Timothy 4:8.

We must thank President MacKinnon for the Christmas Reception for Retirees held on December 15th. In spite of the cold weather, it was well attended and provided an excellent opportunity for members to meet with the President and with each other. For many, the comeand-go nature of the event became a come-and-stay social occasion. The President's Reception was a great success.

On the educational agenda, two sessions have been held. On December 4th, Ron Marken made an excellent presentation on "Pigs in Literature." Although he is of Scandinavian ancestry, Ron did justice to this Irish topic. As a former university administrator, I could personally identify with the poem on the problems and strategies in putting a pig into a half-ton truck; however, the instructions were belated. On January 22nd, Vera Pezer described her first year as Chancellor of the University and her trip to Russia. No. the title was not "The Chancellor was sent to Siberia." It was a reflective statement on dedicating her initial efforts to providing outreach within the Province of Saskatchewan, and to attempting to promote 'Chancellor's Tours' as an alumni activity. Future tours look verv attractive. We thank both Ron and Vera for providing us with excellent educational sessions.

As noted in the November Newsletter, actions have been taken by Kurt Tischler and Bob Sanche on the "International Student Initiative" of the USRA. One option the Executive had considered under this initiative was to develop a needy student fund for international students. Kurt has learned, with the international students now being able to access the general university Dyer Fund,

our best approach may be to bolster the funding of the existing International Student Emergency Loan and Bursary Fund for undergraduate and graduate students. Kurt and Robert have been exploring possible venues whereby faculty and retirees could contribute to the fund through the United Way charitable donation system and through the University development funds. The check-off option does not appear to be available to us. It should be noted that the role of the USRA would be to serve as an advocate and not as the funding agency. Through our meetings with Doug Clark and Gail Shivak of the University Advancement Office, progress is being made and the plan should be in place by the end of the 2008-2009 academic vear. While the scholarshipbursary fundraising supper and airport reception activities are being explored, there is waning enthusiasm for these initiatives.

Given Christmas holidays and the start of the new term, limited progress has been made on the other initiatives outlined in the November Newsletter.

At the request of David Gibson of the Saskatoon Health Region, Jim Blackburn and I, from the USRA, and Mrs. June Gawdun, from the Saskatoon Council on Aging, met to discuss the possibility of USRA members assisting in joint literature research and the development of position papers related to issues faced by older adults. In part, the goal would be to promote informed advocacy. Among the immediate issues to be addressed were affordable housing, administration and availability of personal care homes, abuse of seniors, and some health-related issues. Before we become involved in such activities, the Executive must address the policy issue of USRA serving the role of advocate in the greater community. However, if members of the USRA would like to provide some volunteer services on their own initiative, Dave Gibson would be pleased to hear from you. Being old, I believe the cause is most honourable.

While there is much activity, it is my hope that we can inform the membership of some more results in the next newsletter.
