

We are now well into August, so the falling leaves and cooler temperatures will not be far behind. Even though Saskatchewan has received record rainfall during the last four months, we hope that you have had an enjoyable summer with family and friends.

As noted in the last Newsletter, we have been meeting with university representatives to explore opportunities to further engage retirees in the life of the university. Working groups were established to address such issues as mentorship for faculty and research staff, identifying and nominating candidates for honorary degrees, recruitment of students, volunteer engagement, advisory capacities and engagement with external partners. In most

instances, the volunteer involvement may be consultative and have a finite duration. In other areas, the engagement process may be a bit more complex and require some additional consideration before finalizing the process.

Gleanings From the Minutes

(This column highlights items of interest from the Minutes of Executive Committee meetings)

April 5 Executive Minutes

- Committee Chair Murray Scharf reported that the Photography Workshop was excellent, though there were only 5 participants. There was a suggestion that early (and perhaps several) e-mail reminders about USRA events be sent.
- Duff Spafford reviewed the eligibility rules and process for nominating retirees for the Prime of Life Achievement Awards. Any two nominators from the community can propose a candidate, and a nominee's CV is no longer required.
- On a motion by Faye Kernan, seconded by Duff Spafford, Eileen Harvey was commended for her excellent work as Chair of the Prime of Life Achievement Award Committee.
- Chair Michael Hayden reported on the ongoing work of the Ad hoc Committee on the Future Role of the USRA.
- The Nominating Committee for 2010/11 was established, with Murray Scharf, Dale Miguelon, and Kurt Tischler as members.

May 3rd Executive Minutes

- In Business Arising From the Minutes, it was agreed not to have a formal component to the spring barbecue and to emphasize instead visiting and socializing. In correspondence, Jim noted that he had received an invitation from the university to attend and speak at the annual retirees' banquet. He will obtain the new retirees' list early and extend an invitation for all to join the USRA.
- Chairman Murray Scharf reminded members of the executive of the Batoche historical tour and the June 4th horticultural tour.
- The Executive Committee agreed to hold the speaker series at Mano's Restaurant for the coming year. Dr. Stuart Houston offered to speak about his latest book at the first speaker's event in the fall.
- Duff Spafford noted that the name of the committee has been changed from "Prime

- of Life Achievement Awards Committee" to "Achievement Awards Committee."
- Duff Spafford will attend the CURAC Conference at York University on May 18th as the USRA representative.
- Michael Hayden reported on the progress made by the Ad hoc Committee on the Future Role of the USRA.
- Dean Jones, the new webmaster for the association, led a discussion of the items the Executive Committee felt should be included on the USRA web site. Further suggestions will be sought from the membership through the USRA Newsletter.

June 7th Executive Minutes

- In Business Arising from the Minutes, Jim Blackburn noted that the USRA website had been updated, and he encouraged executive members to review the changes. Final details of arrangements for the June 7th spring barbecue were presented. Correspondence received indicated that neither President MacKinnon nor Chancellor Vera Pezer would be able to attend the barbecue. Also, both Jim Blackburn and Duff Spafford received e-mail messages from CURAC requesting help to host the 2011 CURAC conference.
- Treasurer Ken Smith presented a written financial report showing a small deficit, which he expected would be eliminated by the end of the year.
- Eileen Harvey, chair of the Prime of Life
 Achievement Awards Committee, presented
 the names of 10 people recommended for
 the award in 2010 and the Executive
 Committee approved the awards.
- Following discussion, the Executive decided on a format for making the award presentations at the awards dinner.
 Chairman Jim Blackburn thanked Eileen and the whole Prime of Life Awards
 Committee for their good work.
- There was discussion of how the USRA could support the University of Regina Retirees Association in hosting the 2011 CURAC Conference. The decision was to make a modest financial contribution and/or to participate in some element of the program

- that might be related to aboriginal education.
- The Ad hoc Committee on the Future Role of the USRA did not report, since the Chair was out of town. Jim Blackburn noted that the Ad hoc Committee had a scheduled meeting for June 24 with senior university administration.

8th Annual CURAC Conference

The eighth annual conference of CURAC (College and University Retiree Associations of Canada) was held at York University, Toronto, May 18-20, 2010. There were 68 registrants, representing 28 local retiree associations. Topics discussed in the formal sessions included the impact of the recession on university pension plans, discrimination on the basis of age, post-retirement health needs, how retirees can take part in university activities, and preparation for retirement. On the last

topic, the UBC retirement association submitted a report which lists matters to be considered in arranging retirement living (right down to "things to consider no longer doing") and includes useful references and Web sites; the report can be accessed at

www.ubcemeriti.org/Preparation.html. The host university's retirement association reported on the experience of York's Retirement Planning Centre, which has been operating since 1984 providing library resources, seminars and individual counselling for faculty and staff at all stages of their working lives. Opening of a new facility at the University of Toronto, the Academic Retiree Centre, was announced; the Centre offers, among other things, work space for retirees.

Much discussed in the conference sessions and in the hallways was the fallout from the abandonment of mandatory retirement at Canadian universities. Given the choice, university teachers have been staying on after the notional age of retirement in considerable numbers; at one university, 90 per cent stayed on over the last three years, it was reported. While this is going on, the number of people opting for early retirement also is tending to increase, so the actual age of retirement is becoming ever more diffuse.

Retirement living on a university campus, an idea that has caught on in the United States, has so far been taken up in Canada only at the University of Guelph. This autumn, a second Canadian application of the idea will be opened on the UBC campus. Tapestry at Wesbrook Village is a complex of 180 units, including both condominiums and rental apartments.

CURAC has adopted aboriginal post-secondary education as an area of special interest, and it is a topic that is likely to receive some emphasis at CURAC's next annual conference, to be held at the University of Regina, May 11-13, 2011.
